Traditional pedagogical approaches may conflict with the introduction of AI-based learning tools, leading to resistance from parents, educators, and policymakers. Concerns about privacy, data security, and the ethical use of AI further complicate its integration into the curriculum. Furthermore, there is a gap in research and evidence-based practices regarding the efficacy of AI in early childhood education specific to the Nigerian context. Limited studies exist to guide

policymakers and educators in implementing AI responsibly and ensuring its alignment with cultural norms and educational goals. Addressing these challenges requires a multifaceted approach. Investments in infrastructure, teacher training programs, and research initiatives are essential to build the necessary foundation for AI integration. Collaboration between government agencies, educational institutions, and technology developers can facilitate the development of culturally relevant AI solutions tailored to the needs of Nigerian early childhood care settings.

Ng et.al., (2022), on the other hand sought to overcome the challenge of understanding AI at an early age by carrying out what they call AI literacy using digital stories. Digital stories are inquiry based pedagogical approach used in demystifying the technologies behind AI concepts.

These tools can turn learning into a playful and enjoyable experience, which is especially important for pre-schoolers'.

Multisensory Learning: AI can facilitate multisensory learning experiences that involve visual, auditory, and kinesthetic elements. This approach can help reinforce concepts and cater to different learning styles, making education more inclusive.

2. Limited Digital Literacy

Basic Technology Skills: Many pre-schoolers have limited experience with technology. Introducing AI tools requires a certain level of digital literacy, which may not yet be developed in very young children. This can limit their ability to interact effectively with AI-driven educational tools.

Reliance on Adults: Because of their limited digital literacy, preschoolers often need significant guidance from parents or teachers to use AI tools. This reliance can reduce the potential benefits of AI by making it less accessible to children who do not have consistent adult support.

3. Technological Barriers

Access to Devices and Connectivity: In many regions, particularly in developing countries, access to digital devices and reliable internet connectivity is limited. This technological gap can hinder the widespread adoption of AI in early childhood education.

Usability of AI Tools: Designing AI tools that are intuitive and easy for young children to use is a significant challenge. Interfaces must be simple, engaging, and error-tolerant to accommodate the learning styles of preschoolers.

Finland: Known for its progressive education system, Finland has introduced AI in early childhood education by using adaptive learning environments and AI-assisted teaching methods, which are designed to foster creativity and problem-solving skills in young learners (Kontkanel *et. al.*, 2023).

These strategies highlight the importance of a comprehensive approach that includes technology, teacher training, curriculum adaptation, ethical considerations, and stakeholder engagement. By following these steps, developed countries have been able to successfully introduce AI into early childhood care, creating a more personalized, efficient, and engaging

learning environment for young children.

Conclusion

Su, Ng and Chu (2023) specifically mentioned lack of a curriculum design as a challenge hindering the adoption of AI in ECCE.
